

There are two categories of claims against Cuba: (1) those primarily related to the expropriation of property owned by U.S. nationals and adjudicated by the Foreign Claims Settlement Commission (FCSC), estimated at \$8 billion (including interest); and (2) those related to unsatisfied terrorism-related court judgments against Cuba, estimated at \$2.16 billion (not including punitive damages or interest). Mark: good to hear from you. A few clarifications. One, USAID asked my firm to do this work during the first Bush (W) administration, not Clinton. I believe it was in 2001, before 9/11. Two, we never completed the project, and we never actually signed a USAID contract. The contract was pending and going through drafts, but we were working on the assignment on the expectation we would eventually finalize an agreement and receive payment. Unfortunately, the White House decided to pull the project and we dropped our pens and closed the books. Hence, the draft is incomplete.
