Dear Mr. Poblete:

We refer you to our letter dated June 2, 2022, regarding the release of certain Department of State ("Department") records under the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552. The Department has identified four additional responsive records subject to the FOIA. We have determined that one record can be released in full and three records may be released in part.

An enclosure explains the FOIA exemptions and other grounds for withholding material. Where we have made excisions, the applicable FOIA exemptions are marked on each document. All non-exempt material that is reasonably segregable from the exempt material has been released and is enclosed.

## The Freedom of Information Act (5 USC 552)

#### FOIA Exemptions

Dear Mr. Gutiérrez:

Thank you for your letter of April 13 to Assistant Secretary of State for Western Hemisphere Affairs Roberta Jacobson regarding enforcement of Title IV of the LIBERTAD Act in regard to Grupo Sol Meliá, Bouyges Construction Group, and Standing Feather International, Inc. Assistant Secretary Jacobson asked that I respond on her behalf.

The Department reviews cases alleging trafficking in confiscated property in Cuba on an ongoing basis. Title IV of the LIBERTAD Act and the Department's implementing regulations set forth various factors necessary to a determination trafficking in confiscated property has taken or is taking place. As you know, among these are the requirements that any qualifying acts of trafficking occurred subsequent to the entry into force of LIBERTAD, and that trafficking or involvement with the confiscated property has not ceased at the time of determination. The Department continuously and meticulously examines the facts and documents in its possession in each case, in order to determine whether to make a trafficking determination. Arriving at a final determination can often be a lengthy process.

# Cuba


Title V of the International Claims Settlement Act of 1949, as amended [Public Law 88-666, approved October 16, 1964, 73 Stat. 1110 (22 U.S.C. 1643)] authorized the Foreign Claims Settlement Commission (Commission) to adjudicate claims of U. S. nationals against the Government of Cuba for losses from the nationalization, expropriation, intervention, or other takings of, or special measures directed against, property (as well as for disability or death of United States nationals resulting from actions taken by or under the authority of that government) that occurred between January 1, 1959 and May 1, 1967.

The Commission completed the Cuban Claims Program on July 6, 1972, and certified to the Secretary of State 5,911 claims, currently worth more than \$6 billion with interest. These claims would serve as the basis for any claims settlement negotiation with a future Cuban Government amenable to such discussions. Payment of these claims therefore awaits the negotiation and conclusion of a claims settlement agreement with Cuba. A total of 2,905 claims submitted to the Commission's Cuban Claims Program were denied certification because they lacked supporting documentation or did not have U.S. nationality.

On July 15, 2005, the Secretary of State referred an additional category of claims against Cuba for property loss to the Commission for adjudication. The category consists of claims that would have been eligible under the first program but for the fact that they did not arise by the time of the original filing deadline or were not otherwise adjudicated before that program closed. The filing deadline for these new claims was February 13, 2006. During this period, five claims were submitted to the Commission. Of the five claims, two were found to be valid and were adjudicated and certified to the Department of State.
