Mary and Rich,

Tess called us last week to ask for background on Cuba claims, indicating that there was growing interest on this at the NSC, in connection with further regulatory changes that could be made. We gave her the run down on U.S. claims against Cuba, and Cuba's claims against the U.S. We discussed both the FCSC certified claims (and meetings we had with certain holders of large claims) and the VOT claims and the challenges presented by the judgments. Finally, we provided a readout of the first round of claims talks we had in December. Following the call, we forwarded to her the papers and TPs we prepared for the December talks.

Since then, and based on the email below, it would appear that Avril and Ben Rhodes are seeking a briefing on claims and that D would participate. I wanted to make you aware of this, both to put it on your radar in the event you are approached separately and also to see if you have any suggestions about how to manage this. I have a call in to Tess to see if she knows anything further. I have also been keeping Mark Wells (WHA/CCA) in the loop on all of this. We are preparing materials that could be used for a briefing, in addition to an options paper to help focus thinking on options for the next round with Cuba, which would occur in Washington in the March/April time frame.
